

COMPATRIOT LEE EDWARD BISHOP, JR. PASSES AWAY



We are saddened to have to report that Compatriot Lee Bishop passed away in the early hours of December 8th. Lee joined the Los Angeles Chapter, SAR in 1984 and transferred to our

Chapter in 2000. Lee was a regular at our monthly meetings ever since and he served as our First Vice Presidents in

2000. Lee was always prepared to substitute when a scheduled speaker was a no show, and more often then not his talk proved to be

more interesting.

Lee was a native Californian, born right here in Los Angeles on September 12th, 1932, the son of Lee and Frene (Borger) Bishop. He graduated from Santa Monica College and served in the United States Navy and, the United States Army, Field Artillery, and in the Army reserves for a total of eight years.

He worked as a flight dispatcher for Allied-Signal Aerospace and United Airlines. He married Jennifer (Johnson) on February

14th, 1975. Jennifer is an active DAR, a member of our Ladies Auxiliary and also a regular at our meetings.

Lee was extremely active in the lineage society community and often in leadership positions. Most recently he was the founding Governor of the Southern California Sons and Daughters of the Pilgrims. He served as State President of the Sons of the Revolution, and was elected President Emeritus, Commander California Society of the Military Order of Foreign, President of the California Society of the War of 1812, President of Orders and Medals Society of America. In addition Lee was a member of the American Legion, Society of Colonial Wars, Sons of American Colonists, Colonial Order of the Acom, Veteran Corps of Artillery in the State of New

> York, Order of Loyalists and Patriots of the American Revolution, Military Order of the Loyal Legion, National Rifle Association, and the California Rifle and Pistol Association.



Colonel Benjamin Tallmadge's Tribute to

General George Washington

Colonel Benjamin Tallmadge (February 11th, 1754 March 7th, 1835) served during the Revolutionary War as a Major in the 2nd Continental Light Dragoons.

He became General Washington's Chief Intelligence Officer, and his service to the cause of American Independence was second to none. After the war he was active in the settling of the Ohio Valley and served as a Congressman from Connecticut. His January 11th, 1800 letter was written to the

Reverend Manasseh Cutler (May 13th, 1742

- July 28th, 1723). Cutler, also a veteran of the Revolution was active in getting the Ohio area settled and was the founder of Ohio University and served as a Connecticut Congressman.

This letter can be found in Ephraim C. Dawes Papers, Midwest Manuscript Collection, The Newberry Library, Chicago. Dawes was a greatgrandson of the Rev. Manasseh Cutler.

> "Litchfield [Conn.] Jan. 11, 1800

Dear Sir;

I have now before me your letter of the 23d ultimo for which I thank you. It is really pleasing to find that people begin to open their true interest in the Ohio Company. I have not yet conversed with one person in this State, who appears

Our Country seems to be clad in real mourning for the loss of our great benefactor, patriot and friend, the illustrious Washington. I can truly say that the loss of my own father did not so sensibly affect me as has the death of this peerless man. While he lived, I was fully satisfied that his equal was not on Earth, and since he has died, the public testimony to his worth, has exceeded even the most sanguine expectation. Altho'

from a long and tolerable intimate acquaintance with him, I have been abundantly convinced of his attachment to the Christian System. vet had he been explicit in his profession of faith in and dependence on the finished atonement of our glorious Redeemer for acceptance and pardon, what a conspicuous trait would it have formed in his illustrious character. In removing such high and elevated personage, from the stage of action, how astonishingly great and glorious does the divine character Let poor grovelappear. ing mortals quarrel as they please, his undisturbed Government and purposes roll on, and his whole counsel shall stand. How perfectly becoming is it for us, and
